Due to your strange efforts I am honored to have been François Légeret's team mate - imprisoned since 10 ½ years - in the carpentry of the high security jail at Bochuz/Orbe.

You have been the sinister architect of his lifelong sentence, based exclusively on your dark imagination. You have had the complicity of the following magistrates who are reading me by registered mail containing a copy of the book «L'affaire Légeret – Un assassin imaginaire» by Jacques Secrétan, Edition Mon Village, May 2016:

After reading the book «L'affaire Légeret – Un assassin imaginaire», you have alltogether the opportunity to make amend by producing a public declaration. I have given to you the example: In 2010, I became aware that I had been sneakily entangled in a «grey» judiciary case of Fribourg during 9 years. I resigned from the Presidency of the citizens initiative called APPEAL TO THE PEOPLE. The consequences of your blunders are far more catastrophic.

With the Légeret and Ségalat cases, the Supreme Federal Court of Switzerland and the European Court for Human Rights have attracted a total discredit on them. According to Dr Hans Hurter, a lawyer in Luzern, this latter instance is the greatest factory of injustice in the entire world. This system is breeding arrogant and corrupt magistrates – not only in Switzerland. To be abolished!

*I am a mature man (born in 1944), having struggled during 16 years nonviolently against the judiciary arbitrariness. My critical mind has made magistrates hate me blindly. They took their revenge by jailing me for 4 years. This was an opportunity to complete my knowledge of their tyranny. At the high security jail of Bochuz/Orbe VD I teamed up with another victim of the magistrates' stupidity, François Légeret. A favour of destiny. Thanks to these circumstances, I got access to his procedural files. And **I felt the unbearable sufferings of this man, sacrificed on the altar of «the inner conviction of judges»**. In contrast with me, François Légeret (jailed since 10 ½ years) cannot understand why he had become the subject of the magistrates' obsession. *What concerns me, I have not at all been destabilized by my experience in prison. With relaxation, I am seeking the dialogue with politicians, trusting to share with them my rich experience on how the judiciary apparatus dysfunctions. **The royal road out of this crises exists!***
