Challenge

Mr. Attorney General,

On March 22, 2016, I lodged a complaint against Yves Nicolet, your former «Prosecutor», promoted to federal «Prosecutor», for illegal censorship of the Internet and abuse of authority at the Attorney General of the Confederation. Since this complaint was left unanswered I lodged on July 3rd 2016 a complaint for denial of justice addressed to Mrs. Nicoletta della Valle, FedPol. On July 21, 2016, she had the complaint for denial of justice transferred to the Prosecutor's Office of the Confederation. But the letter from the Deputy Attorney General of the Confederation, Ruedi Montanari, dated July 27, 2016 informs me that my complaint against Nicolet has been passed on to the Prosecutor's Office of the canton of Vaud.

Indeed, it goes without saying that I challenge you, together with all your staff, invoking your obvious partiality with regard to my person. Evidence: our exchange of correspondence – your letter dated March 18, and my reply of March 21, 2016 (see attached copies). And if the boss is partial, his subordinates will follow by loyalty your partiality.

*To the attention of the authority which will finally be in charge to investigate my complaint against Nicolet, there are some news to be provided:
When consulting recently the file PE06.029485-YNT/EMM/ACP – [Michel Tinguely contra Gerhard Ulrich](#), I discovered suddenly a bunch of papers concerning the*

ensorship of my web sites. Nicolet, who has been in charge of this file has always claimed that the censorship was not part of my file. And his successor, Coletta Stéphane informed my lawyer ex officio afterwards that these papers were indeed not part of this file.

Already on April 14, 2014 (evidence in the file) I accused Nicolet to make use of the highly poisonous and illegal practice of the double file – one accessible to the accused, and another one, more voluminous, exploited exclusively by the investigators. It is obvious that a fatal error has occurred recently in your services. The practice of the double file seems to be the rule in your mess, and the mentioned documents have ended up by accident in the file accessible to me. Sooner or later such an error risked to occur.

You do not have the exclusivity for practising the double file. In the framework of the file URA VU.2004.48 (triggered off by 8 federal judges in August 2004 against me for pretended constraint, ending with my acquittal on April 15, 2010 at the Federal Penal Court) the «Prosecutors» and investigating federal «judges» were cheating the same way. During that investigation, they had the architect Erhard Keller called to Berne in 2005. Questioned, he confirmed point by point the correctness of my denunciations against the federal «judge» [Roland Max Schneider](#) to be corrupt and a crook. Since this information was obviously disturbing the objective to have me condemned, the dark chamber of the Nation did make use as well of the odious double file practice, for filing the information provided by Mr. Keller in a flap inaccessible to me. This spring, 11 years later, Mr. Keller told me that fact incidentally. Subsequently, I suffered an enormous moral damage. The Penal Federal «judge» Miriam Forni exploited the situation by slandering me via mass media ex officio.

The present letter serves as a denunciation of this abuse of authority, implying presumably the investigating federal «judges» Ernst Roduner and Jürg Zinglé, as well as the federal «Prosecutor» Hansjörg Stadler.

All these cheatings aimed the repression of the Freedom of Expression and are connected one to another. Nor you, Mr. Cottier, nor your fellow federal clerk Michael Lauber can take in charge the investigation of this affair, since you did place yourself together with yours staffs outlaw in my regard.
