Mrs Federal Councillor,

As you know, I assisted on August 31st, 2016 with the walkabout (approximately 500 persons), which the Federal Council offered-itself after its meeting ex muros in Glaris.

I was wearing a yellow T-shirt with the names printed in black of François Légeret on the front and Laurent Ségalat on the back. These are the two victims of the judiciary crime, well known to you. This has been the fear of our seven sages, since I managed to present my-self repeatedly to each one at a distance of 1 to 2 m – with the exception of Alain Berset who had vanished rather quickly. I observed a certain disarray of our federal Councillors. None of you showed any interest to discuss with me. I did make the long trip with the objective to communicate with you, but my effort did not bring any result.

However, being a man of mature age and with my experience of life, I have to offer to you useful knowledge.

During the check beforehand, the policeman Störchlin had taken off from me the seven envelops, containing my press release of August 30, 2016, aimed to be transmitted to our Federal Councillors. He had promised to have the envelopes submitted to the addressees. Nevertheless, I attach a copy to this release.

*Mrs Federal Councillor, you did not confirm receipt of **my 4th denunciation** of the corrupted and fraudulent federal Judge R.M. Schneider, dated August 20th, 2016, lacking thus what the Anglo-Saxons call «administrative politeness». Daniel Kipfer-Fasciati, President of the Penal Federal Court just has returned to me his copy together with the mail envelop, with the cheap excuse that this denunciation did not fall in his competence, and overlooking the NB at the foot of the letter: «Denunciation to be transmitted to the competent authority». See enclosed copy. This way, his archives do not contain any longer unwanted traces, in opposition to the URL www.worldcorruption.info/schneider.htm*

The Ostrich behaviour of the Federal Council indicates that he continues to stand with Goliath – the obsolete judiciary system, whereas the firepower of David is daily increasing. Does the acting Federal Council want to go down in History as the one who did not find the valour to clean out this Augean Stable?
