### **Notice**

***Concerning the denunciation of the corrupt/embezzling federal Judge Schneider  
(My mails of August 20th and September 3rd, 2016)***

*On June 28th, 2007 the «Judge» Bertrand Sauterel asked my youngest sister, Gertrud Schudel- Ulrich if one could not stop her brother to criticize the Judges. Instant reply: «No. Never! As you know, our obsolete judiciary system is not even able to resolve these two worst of their scandals. You have been briefed as well that these two men have been condemned wrongly to long prison sentences. It was obvious that our Federal Councillors were embarrassed in Glaris that I recalled to them these names.*

*Nor you, nor the government clerks/politicians who had received copy of my denunciation of the corrupt and fraudulent federal «Judge» did react to my mails of August 20th and September 3th, 2016, in spite of the NB in the letter foot: «Denunciation to be passed on to the competent authority». On page 8 in medio of this document (which will be soon published), these disloyal Magistrates pretend that the CHF 390'000 cashed in by Schneider on September 15, 1992 from Zurich insurance company did have nothing to do with the ATF 4C.118/1998 of June 27, 2000 granting to Schneider an amount of CHF 93'694 + 5 % interests starting from June 6, 1992, under deduction of the outstanding architects fees of CHF 19'562 + 5 % interests, starting from March 8, 1990.
