*Simonetta SOMMARUGA, chief of the Federal Department of Justice and Police did not provide the slightest feedback to my denunciation of [August 20, 2016](#) of the corrupt and fraudulent federal «Judge» **Roland Max SCHNEIDER**. On [November 23, 2016](#) I addressed my 5th denunciation of this criminal to the President of the Federal Court, with copies to all 152 federal Judges, the 7 Federal Councillors and their spouses, the federal Chancellor, the 200 National Councillors and the 46 Senators, offering a deadline of December 15, 2016 to act. The deadline has been reached, and the evidence irrefutably administered that SCHNEIDER is part of that Nomenclature who is enjoying immunity to fraud, immunity supported by the hidden Oligarchy of this country. SCHNEIDER knows too much.*

The Finance expert Harry HEUTSCHI has proven in 1998 that the national assets of the Swiss population at the AVS/AI is spoiled by a gang of selected Banksters protected by the federal administration, the Executive, Legislative and the Judiciary. At that time, he estimated the losses to amount to 34 Billion of CHF. Since this fraud is continuing up to date, he calculated this corruption sum to have reached today 800 Billions. This is the century betrayal of the Swiss Nation.

At the end of the Gulf war in 1991, the oil wells set on fire by the soldiers of Saddam HUSSEIN were extinguished and mastered with the patented inventions of Joseph FERRAYÉ. The offer of FERRAYÉ amounted to 34.92 Billion of US\$ (1164 x 30 Million per extinguished/mastered well in a rapid intervention). A plot of powerful men of various Nations, including Swiss Banksters, Magistrates and Oligarchs alienated these inventions and cheated the inventor. They doubled the bill and Iraq was ransomed by oil furniture, under a program called hypocritically «oil for food». Beyond these 70 Billions of US\$ 70 in addition to the original offer, the patents were sold to all oil producing countries at the price of 30 Million US\$ x 120'000 active wells = 3600 Billions, the initial sum of the war booty. Marc-Etienne BURDET estimates that 1/3 – 1200 Billions of that sum transited through Switzerland, bypassing taxation. Loss of revenue, only for the Swiss Confederation: 120 Billions US\$ (3 years of the annual expenses of the Swiss Confederation in those years) at a taxation rate of 10 %. BURDET estimates the amount of these corruption to have grown today to over 30'000 Billions of CHF.
