## ***Request to cancel the condemnations of all Members of APPEAL TO THE PEOPLE***

*To you, **MEYER**,*

*The citizens' initiative/association of judiciary victims APPEAL TO THE PEOPLE, founded in 2000 was based on the Constitutional State and the traditional values of Switzerland, both granted by the Federal Constitution. Having discovered serious dysfunctions of the judiciary apparatus, the association pursued the objectif to sanitize the judiciary apparatus, by calling to order the defaulting Magistrates by means of leaflet distributions and publications on Internet.*

*Our judiciary Magistrates are acting according to the labels of their political parties and placed in office by politicians who did loose their independence a long time ago – as documented by the motivation of their challenge, accessible under the link [www.worldcorruption.info/index\\_htm\\_files/motivation\\_recusations.pdf](http://www.worldcorruption.info/index_htm_files/motivation_recusations.pdf) – Since many years, they are not any more able to respect the duties of their charges. The only objectif fixed for them is to preserve the financial interests of a hidden Oligarchy, who's methods are to be assimilated with an organized criminal gang, practicing fraud and money laundry. **The Constitutional State is not any more existent**, and our Magistrates are not capable of challenging themselves! Consequently, the actual judiciary system is irredeemably degenerated, thus irreformable with the elected actors in office. Only the application of the **7 requests addressed to the Federal Council** on May 23 2015 will straighten the situation.*

*The judiciary tyranny did need 6 years for setting the scene for the first show trial against APPEAL TO THE PEOPLE in 2006 before the court of **WINZAP**, followed by another spectacle in 2007 before the court of **SAUTEREL**. *Other trials in various Cantons in the same style followed. The excessive revenge is obvious, since three leaders of APPEAL TO THE PEOPLE – Gerhard ULRICH, Marc-Etienne BURDET and Daniel CONUS – were condemned to a total of 10 years in prison (= political prisoners), without partial remission of the sentence, in spite of correct behaviour during the imprisonment. Half a dozen of other activists were condemned to prison sentences with reprieve, and were **heavily ransomed** financially. However, there was nor theft nor murder. Our «crimes» just consisted in the distribution of leaflets, the publication of crimes committed by the Members of the judiciary apparatus on Internet and the oral information spread publicly... The racket is still going on today, by abusive procedures payed partly by the tax payers, inconsiderate court fees and cost allowances to the plaintiffs who are in fact nothing else than criminal Members of the Freemasonry!*

*The non violence has always been our conduct of behaviour. Liberated from jail, we continue to publish the pitiful situation of our alleged Constitutional State.
