### ***Proposal for an amicable settlement***

To you, Pascal, BROULIS,

Reference is made to my denunciation of the State Councillor BROULIS for mismanagement and membership of a criminal organization of [10.12.16](#). Obviously, this had not been submitted to the competent authority, as the Law is requesting it, and as it was specified in the concern. Herewith I file a complaint for judiciary denial, to be transmitted to the competent authority.

You and your cronies at the Vaudois State Council did not contest the content of my mail of [10.12.16](#) nor my mail dated [18.07.17](#). This has to be assimilated with a tacit admission for mismanagement and membership to a criminal organization. Among the 3 PLR Councillors of State, you are as an ex-bankster the only financial expert. Since the world is ruled by money, one has to presume you to be their leader. In your Council, you do have a majority of leftish politicians, who are rather docile, and since your Parliament is having a Majority of the right parties, your PLR – historical leader in this Canton – is still leading the way as in the past. Evidently, above the government, you are receiving your instructions from the hidden powers, e.g. from the Bilderberger André KUDELSKI and the Grand Master of the Lodge Alpina, Jean-Michel MASCHERPA. These hidden powers are appointing the judiciary Magistrates, who are producing the decisions convenient to them. The Nomenclatura «is not satisfied to have mediocre Magistrates. She is selecting and breeding them to be mediocre ». *Idem* in many other Cantons, and at the federal level. In Switzerland, «Justice is not brought in the name of the people but by hidden powers».
