***The affair GAIFFE,
or the high art of judiciary banditism***

Madame Minister of Justice,

As a Minister of Justice, you should impose the ideal of Justice. However, it is well known that the French magistrature is in the grip of the Freemasonry. You have just to consult the Internet. Actually, France is not the only country in this world, where the judiciary apparatus is at the service of the dominant citizens. In Europe, this cartel is overseen by the European Court of Human Rights, and the planet is managed by the New World Order of the Bilderbergers. The whole humanity is victim of this global plot. The judiciary victims are just a category of especially abused slaves. But watch out, people are waking up! The oligarchs shall be astonished to acknowledge, what we know about them.

Being myself a former and future political prisoner of Switzerland, I was living from July 7, 2007 until March 6, 2009 in the underground. I had the time to investigate in the Web and did discover among others the French affair of Louis

GAIFFE. I was impressed that a detainee managed to run an Internet portal from out his jail. This man is since 1998 in the ambush of the Freemasonry magistrature. It is the story of a family father who was intentionally wrongly condemned for an alleged commanded sequestration and assassination. Subsequently, he was spoiled of his total considerable wealth and is fighting since 21 for his rights.

I was fascinated by this affair. Although I distance myself from the anti-Semitic allegations of GAIFFE, I consider him to be a judiciary victim with whom I can identify myself.

On September 5, 2018 a trial took place at the Court of Appeals of Aix-en-Provence, Louis GAIFFE c/ the frauding Lawyer Pierre MARTEL. This concerned a secondary battlefield, being part of the primary trickery. Curious, I made the trip together with an other international and a French trial observer for assisting at this performance. Enclosed, you find my corresponding trial report.

You, who did reach the top of the French Republic, you certainly cannot ignore the really existing hostage taking of the French population by the Freemasonic Lawyers and government Officers.

Anyway, you may ignore the sufferings which are resulting.
