**Public and contradictory hearing concerning **Rita ROSENSTIEL** (94)**

Mister **COURDESSE**,  
Ladies and Gentlemen of the cantonal Parliament,

Referemce is made to your invitation to come together with Mrs. **ROSENSTIEL** on January 23<sup>rd</sup>, 2019 at 2 :30 p.m. before of your Commission, 3<sup>rd</sup> floor, place du Château 6 in Lausanne. The request that this hearing shall be contradictory and public is reiterated.

Such parliamentarian commissions are hunting down the petitions of citizens almost everywhere in Europe, always according to the same scheme: after the written or oral hearing of the petitioner, one does invite separatly an Officer of the State who will then present his lies, which cannot be contested. Their allegations become the procedural truth, retained by the politicians. **The publicity and contradictory are a must.**

It is known that Mrs. **ROSENSTIEL** is enduring since almost five years the traumatic effects of her forced placement in a nursing home, as well as the theft / distruction of her belongings. **The State has never appologized, has never made a serious attempt to repair.** In the contrary, **MAILLARD** (State Councillor),

***KALTENRIEDER** («President» of the cantonal court) and **COTTIER** («Attorney General») continue to abuse of this respectable 94 years old Lady, for protecting obstinately the guilty cronies. See her letters in French of [November 16, 2018](#) to **KALTENRIEDER** with *enclosures*, as well as her mail to her present female curator of [November 17, 2018](#), where she is denouncing the brutality of **COTTIER**.*

*For preparing this hearing, the trio receives small individual questionnaires. They are invited to reply to the presented questions in writing to you and a copy to the undersigned until latest January 15, 2019. Without motivated reply from their side, the allegations contained in these questionnaires will have to be considered uncontested. It goes without saying that the petitioners are having the right to ask them more questions orally during the future hearing, exposing them to the obligation to react spontaneously.*

***The persons who are supporting **Rita ROSENSTIEL** are mobilized herewith to unite from 2 p.m. onwards at the entrance to the hearing room. Subsequently, we shall decide ad hoc, whether we need to react as a Jury of citizens to assume the job which you are probably refusing to do: the efficient survey of the Seraglio from the outside, and to condemn, if appropriate, the corrupt Magistrates. Such a hearing will obviously be contradictory and public. Contradictory, as far as the protagonists will have the courage to show up. In their absence, the uncontested allegations of the parties will have to be respected by such a Jury.***

*If you should object that the hearing facility is not layed out to admit the public, you may alternatively allow to have the debates filmed. A copy of the video will be handed out to Mrs. **ROSENSTIEL**.*

***Please acknowledge that public welfare ought to be debated in public.***
