Madam Jacqueline JEANPIERRE Manager of judicial affairs of the region Rhône Alpes Former Deputy Director of the National Police of the SGAP in LYON renamed SGAMI of LYON

Your abuse of power at the expense of Brigitte BONELLO Your illegal censorship to hide your scheming

To you, Jacqueline JEANPIERRE,

By a simple note called confidential dated May 15, 2008, after having thoroughly harassed a person with cervical osteoarthritis in good standing, you made Brigitte BONELLO, who was physically handicapped, appear to be mentally unbalanced (facts that were largely contradicted by 36 certificates and expert reports. This note of May 15, 2008 reused by the Minister of the Interior on April 24, 2015 was highly defamatory.

You may not always have someone from the Prefect's or Minister of the Interior's network to investigate the forgeries you have committed.

It is also a fact that the complaint procedure against your forgery has been carefully dismissed from the criminal proceedings by the Dean of Investigating Judges of Lyon and entrusted to Judge Catherine CHANEZ DE BALMANN, propelled Vice-President of the Court of Appeal of LYON.

Previously, this procedure was not the subject of any investigation. The victim who requested acts, confrontations, was carefully excluded not only from the hearings but also from the documents in the file. This may not be the case for the current procedure.

Nevertheless, without any court decision being clearly stated, therefore in the most perfect illegality, you have proceeded to close the blog of the support committee of this disabled woman surviving to date, thanks to you of less than \in 500 / month, using a misleading report sent to AMAZON WEB SERVICES.

In doing so, you have offended the law - a right that had not been violated before whatsoever by Prosecutor of the Republic in Lyon, Marc CIMAMONTI, who also had his photo and emails with the Defender of Human Rights online on our Blog. To do so, you have invoked the infringement of your image rights and your privacy.

This is false and quite hilarious in view of what you have done to Brigitte BONELLO through by shamelessly violating her medical data, which you widely used for your so-called "confidential" note, widely distributed by the National Police's litigation services and in the administrative courts.

But Mrs. JEANPIERRE, if the sight of your actions offends you so much, don't commit them!
