Opposition against your penal decision of March 6, 2020, notified on March 12, 2020, condemning me to a fine of CHF 300.- respectively 3 days of prison for alleged 'publication of secret official debates'.

To you, LOGOS Séraphin,

It goes without saying that I timely object to your harebrained prescription. I acknowledge having assisted the Congolese, Djilz ADASMANN to analyze his judicial file, after his scandalous conviction in first instance for alleged intentional arson. This judgment was the result of a botched investigation by Prosecutor General BUGNON, followed by the negligence of the "judge" of first instance, Pascal CHAPPUIS. This allowed me to advise this judicial victim, and to mobilize observers for his appeal trial on December 13, 2017 before the JU Cantonal Court.

The cantonal judges LOGOS, KOHLER and JUBIN corrected this judicial crime, without compensating the victim for the material and moral harm suffered, thus confirming my appreciation. Alas, no journalist showed up at the hearing, although they were notified. For this reason, I took it upon

myself to inform the population of Les Breuleux. Since the fault had been rectified, I refrained at the time from publishing the case on the Internet.

To my surprise, you condemn me more than 2 years later, supposedly for violation of article 293 of the Swiss Penal Code, inspired by a complaint of the Delémontese lawyer Cédric BAUME, wanting to change the interpretation of our laws, to establish a cabinet justice. According to his standards and yours, all journalists reporting on trials would henceforth be equally guilty.

Sir, with your late decision, which you have laid after 2 ½ years of incubation, you are blatantly and serially violating the articles of the European Convention on Human Rights: Article 6 (right to a fair hearing), Article 10 (right to freedom of expression), Article 11 (right to freedom of association) and Article 14 (prohibition of discrimination).

It seems to me that you and your auxiliary, Me BAUME, shot yourselves in your own feet.
