Complaint for denial of justice generates another denial

Appeal in civil and constitutional matters against the judgment QC14.000209-200266 of April 2020 of the Vaudois cantonal Court, notified on April 20, 2020 (enclosure 1) - Deadline : le 20.05.20

Ladies and Gentlemen,

History

Judicial crime committed by an organized gang at my expense has been documented on www.worldcorruption.info/rosenstiel.htm - in case of censorship access via proxy <https://kproxy.com/> and by a wide range of media: www.youtube.com/watch?v=EMk4R5uKgsU

The guilty Justice of Peace, Véronique Loichat Mira, was allowed to continue to mistreat me, covered up by her accomplices in the Vaud judicial mafia. Evidence: My letter of 30 August 2019 addressed to the Justice of Peace of Morges, documenting 41 denials of justice (enclosure 2).

My request for the lifting of guardianship - transfer / release of the balance of my account "moral wrong" of 16 October 2019 also addressed to this body (enclosure 3) has generated a 42nd denial of justice.

On 15 January 2020, I put the Justice of Peace on notice, because of their serial denials of justice (enclosure 4) - in vain.

I was obliged to file a complaint for those serial denials of justice on February 7, 2020 (enclosure 5).

By decision of the cantonal Judges [Joël Krieger](#), [Caroline Kühnlein](#) and [Yasmina Bendani](#), they were just so kind to acknowledge partially the latest denial of justice, resulting from my appeal of October 16, 2019.

On the other hand, they ignored the 41 other denials of justice, documented by enclosure 2 (lies by omission).

Grievance

The unconstitutional bad faith and arbitrariness of the Vaud judicial mafia in my regard have been repeatedly reported to the Federal Court. The federal "Judges", who have up to now been seized of my criminal complaints, have always ruled in complicity with the Vaudois. **This time, these people have bitten their own tails, because my complaint for 42 denials of justice has produced 41 other denials of justice.** It is to be hoped that this appeal, which is submitted to the Civil Law Court of the Federal Supreme Court, will - who knows - fall on fertile ground.

Conclusion

The denials of justice at my expense, as well as the unlawful actions of the Vaud Cantonal Court are to be acknowledged. Having established this, it is appropriate to submit my case to the canton of Zurich, where I am from and where I took refuge, to settle all my claims ignored by the Vaudois, among others to finally compensate at least the material losses suffered - the destruction of my household, insured for CHF 85,000.

Demande de la procédure gratuite

I am entitled for a procedure free of charge, since I am living from my AHV pension and complementary contributions, and I formally request it. If necessary, you will ask the Office des curatelles et tutelles, ch. de Mornex 32, 1014 Lausanne, to provide any additional evidence you may require.
