***The impossibility to lodge a complaint with the United Nations High
Commissioner for Human Rights***

Madam,

According to my observations of many years, it is only in very rare cases that it is possible to file complaints with your High Commissioner's Office. As a rule, the plaintiffs do not even receive an acknowledgement of receipt. In the last 3 months I have written to you 4 (four) times in a given case. Without any success:

The Swiss magazine Plädoyer 2/2020 has praised the UN Special Rapporteur on Torture Nils MELZER. He argued that so-called white torture should also be combated.

So I turned to him with an [open letter of April 18, 2020](#) by A-Post with the request to take up the case of the 96-year-old Rita ROSENSTIEL, who is illtreated by the Swiss authorities (for a summary of the case see the above letter). When nothing came, I sent the above-mentioned letter on May 8, 2020 by registered mail with confirmation of receipt, which was to be handed over personally to Mr. MELZER. On May 21st, 2020 this letter disappeared on Track and Trace of the post office. Upon request, the post office informed me on May 22nd, 2020 that the registered letter had been advised in your post box on May 12, 2020 but had not been collected by May 20, 2020. Therefore I sent the mentioned letter with accompanying letter of May 22nd, 2020 registered to you personally. No reaction. Thereafter that I made the 4th attempt: On June 16, 20 I had the original letter and accompanying letter sent to Mr. MELZER by registered mail with confirmation of receipt. I enclosed all evidences concerning my unsuccessful attempts. On 26.06.20 the post office « NATIONS UNIES 1211 GENEVE »

stamped the return confirmation and sent it back to me (copy in the enclosure). Until today I have not heard anything.

I have thus fully demonstrated the impossibility of being able to explain to the UN Special Rapporteur on Torture, Nils MELZER, the ill-treatment of Ms ROSENSTIEL by the Swiss authorities. It may be that Mr MELZER is an upright defender of human rights. If so, however, your High Commission is so corrupted by infiltrated SOROS officials that incoming mail is systematically filtered.

On May 18, 2020 Mrs. ROSENSTIEL filed her last two appeals with the Swiss Federal Supreme Court. She protested against the fact that the magistrates of Vaud had allocated CHF 10,000 in unearned fees to the lawyer Christine RAPTIS from the taxpayers' treasury, after the latter had frightened her for months as an imposed yet challenged «defender». Secondly, the appeal sent to the Federal Supreme Court that her curatrice had alienated the 20,000 payed by the Canton of Vaud form oral wrongs, for paying, among other things court fees costs and lawyer crooks' fees. All of her 41 requests in this regard ended in denial of justice.

With BGE 5A_387/2020 and BGE 5A_389/2020 - both dated June 3rd, 2020 - Federal Judge Christian HERRMANN (5 negative references in my database) declared both complaints inadmissible. The justice bandit HERRMANN thus confirmed in the last instance the 96-year-old old Lady to have no rights at all.

At least we have succeeded with certain concerns. The attempt by the Judiciary of Vaud to completely patronise Mrs ROSENSTIEL has failed. She was freed from the clutches of the Vaudois and brought to safety in a home for elder people in Zurich. And Mrs ROSENSTIEL does not feel alone. She is my protégé. They did not succeed to prohibit me to visit her.

Now that the attempt to approach the UN Special Rapporteur MELZER has also failed, we have decided to ignore from now on the fraud system orchestrated by the UN and the Council of Europe.

We are aiming for new goals and we will not allow ourselves to be stamped into the ground by the banditry of justice.
