Masquerade Constraint - Protest

Dear Mr. KLÜHR,

On October 10. 2020 I flew with Swiss to Berlin for a demonstration of the Querdenkers against the catastrophic plandemia measure dictated by the WHO, which is globally enforced by the governments of most countries.

On the outward journey with the departure at 08:40 a.m. I was surprised to be told that I had to put on the mask despite a medical masquerade liberation certificate. This was unknown to me when I had booked the ticket. I had assumed that Swiss, like the rest of public transport, would accept the exemption provided by law. I was informed that I should have applied for a form from Swiss in advance and that I should have presented a negative test for Covid-19. I regretted having put the mask on during the whole outward flight, as I suffered from shortness of breath due to two consecutive hospitalizations.

On the return flight from Berlin at 20:10 I was forced by your flight attendant Miguel ANGEL to put on the mask against my will. I announced that I would sue him for coercion because of this. In the meantime I have changed my mind, because the young man is just worried about his job.

I therefore turn to you, as the boss of Swiss, with the following statements:

It is undisputed that Corona has had an insignificant influence on mortality statistics globally. According to the WHO, about 65 million people die every year.

With all the tricks of the trade, about 1 million corona deaths have been counted so far, which is an insignificant 1.5 % share of the natural lethality rate. Dr. med. Heiko SCHÖNIG, chairman of the Covid-19 extra-parliamentary commission of enquiry, sums it up: There is no medical problem. The crisis has been set up by international organised economic crime with the aim of enforcing the Great Economic Resets for the benefit of the criminal cartel. Unlike the ignorant and corrupt politicians and the sold journalist mercenaries, SCHÖNIG knows what he is talking about. His Commission has held 20 hearings with leading scientists and economists:
