

## Profile

Born in 1967. Origin: Aclens VD. Law degree from the University of Lausanne in 1991. Lawyer's license from the canton of Geneva in 1994. Practice of the bar until 1995. Clerk at the cantonal court of Vaud from 1996 to 1997. Registrar at the Criminal Cassation Court of the Swiss Federal Court from 1998 to 2004. As

of January 2005, «judge» at the cantonal court of Vaud; President of the House of civil appeals and of the chamber of legal guardianships of the cantonal court. Elected Federal «Judge» on March 16, 2011 for the Greens political party.

This individual has conserved a clerk character and is quite a self-effacing person. He is the kind of brain hidden behind the crime. They are people with no real profile who are just as dangerous as the dominant magistrates.

By decree of the Federal Court 6B\_264/2011 of July 19, 2011, three Federal «Judges», including Dionysos rejected a decision by the cantonal court of Vaud; and the same team approved the Vaudois to be right, notwithstanding an unchanged situation (ATF 6B\_1/2012 of April 18, 212) in the same case of Kumar KOTECHA (British University professor).

This is an absolutely inconsistent behavior.

In fact, Denys plunged into the judicial crimes with the Laurent SÉGALAT's and Naghi GASHTIKHAH's cases (ATF 6B\_1007/2013 of September 2<sup>nd</sup>, 2015).

DENYS is as well involved in the Freemason conspiracy against the Vaudois farmer **Jakob GUTKNECHT**.
