Born on March 6, 1950 at Airolo. Studies of Law and Economics at the University of Basle. Lawyers patent in 1985. From 1977 to 1978 Lawyer at the Department of Interior and Economics and from 1979 to 1983 secretary of the Justice Department of the Canton of Ticino. From 1980 to 1987 Deputy Judge and from 1988 tile 1995 Judge of the Army

Court of the Canton of Ticino (Plitruk). From 1985 to 2001 first instance Judge of the Leventina (pretore), and as such officer of registry and execution of bankruptcy. From 1999 till 2003 Member of the Council of Magistrates, and its President in 2003. From 2001 till 2003 Judge at the court of appeals, President of the Chamber of penal recourses. Elected federal Judge for the political party PDC on October 1st, 2003.

EUSEBIO did cover by the ATF 1B\_484/2016 of January 11, 2017 the corruption and fraud of his former colleague **Roland Max SCHNEIDER**. As a federal «Judge » he did as well support decisions contrary to the interest of children.

#### **The judiciary crime against the Italian Claudio MOLINARI**

His case is without any doubt possible a judiciary crime, and to be explained exclusively by the incompetence and the gratuitous pride of the government clerks in charge of that investigation.

This family father of two little daughters was living in the frontier region close to the Ticino, who had run an independent business as merchant of precious stones. He had received from one of his suppliers of emeralds in Columbia an offer for the acquisition of a polishing apparatus of such stones. He ordered a first series of devices.

They were dispatched by air freight via Frankfurt. The German customs discovered cocaine hidden in those machines and advised the Ticino authorities.

After the arrival of the devices in the free zone in Chiasso, Claudio MOLINARI unpacked one of them, since he had sold it to an Italian customer of his. He charged it

in his car. After having lunched in a restaurant in Mendrisio, he intended to continue his trip in direction of Italy, but he was arrested and put in pre-trial custody. It would have been more logical to observe and to follow him beyond the border, for catching him in the act of manipulating the narcotics. A collaboration with the Italian police would have been far more complicated, and one had had to share the glory.

In the affair Claudio MOLINARI there do exist two other obvious suspects. On the one hand, a former employee of Claudio MOLINARI, originating from Columbia, named GALLEGO. This man had landed the night prior to the arrest of his boss in Milano. When the wife of his employer informed him of the arrest of her husband, GALLEGO hurried to return to Southern America. On the other side, the second suspect is a former commercial Columbian business partner of Molinari – HINCAPIÉ. He had sold the said devices to Molinari and had dispatched them. HINCAPIÉ is suspected a priori to have hidden the cocaine in the machines, before dispatching them. In any case, the Police should have been searching the source of this supply. But they made no effort in that direction. This makes us think that this would have meant too much work. Instead of carrying out a serious investigation, one preferred to celebrate the great success to have caught an important traffic and to have arrested an international drug lord in the person of MOLINARI.

The flyer below has been distributed in 5'000 copies in Italian language across the canton of Ticino. It has triggered off temporarily quite a positive feedback. Teleticino and the monthly review «L’Inchiesta» picked up the case. The Member of the cantonal Parliament BERGONZOLI got very motivated for defending the affair of Claudio MOLINARI, and he visited him even in the prison of La Stampa. BERGONZOLI asked embarrassing questions during the meetings of the local Ticino Parliament.

The authorities just sat out the crises and the tragic destiny of this family father continued its course. Needless to mention that the Ticino judiciary scum did ruin Claudio MOLINARI not only morally. He ended up completely ruined financially.

At that time, the future federal «Judge» Ivo EUSEBIO has been President of the Chamber of penal recourses of Ticino. In that position, he covered the judiciary crime committed at the costs of Claudio MOLINARI, by rejecting one of his well-motivated challenge requests.

**An innocent Italian crushed by the machine of injustice at the Swiss Federal Court**

Mister President,

It has been the last trial of the «Judge» Franco VERDA, in the meantime condemned for passive corruption. On June 2<sup>nd</sup>, 2000 he condemned Claudio MOLINARI, an Italian citizen with an irreproachable reputation without any proof nor confession (in spite of 203 days kept in isolation (!) – to 6 years in prison, on the sole basis of his inner conviction. VERDA has turned all circumstances into charging circumstantial evidences, overshadowing carefully all exculpatory explanations and arguments.

As soon as this merchant of precious stones has got arrested on April 14, 1999, suspected of drug trafficking, he was mistreated by 3 investigators of the Ticino Police, distorting and eliminating systematically all exculpatory evidences. Already 2 months after his arrest, the presumption of innocence has been violated by the publications of press articles.

Subsequently, the Prosecutor Rosa ITEM, an intimate friend of the mistress of the «Judge» VERDA has orchestrated a phony trial of 4 days, assisted by the defending Lawyer ex officio of the accused, designated by the Mafia judiciary apparatus, Luca PAGANI from Chiasso, who has betrayed his own client. For completing the irregularities, the «Judge» VERDA has signed the judgment at a moment, when he had already been suspended of his function!

At cassation, the cantonal «Judge» Francesco PELLEGRINI has cut the defence speech of Claudio MOLINARI, using the lie that he tried to come back to facts which had already been developed by his Lawyer. No! – Obviously, the whole Ticino judiciary apparatus is afraid that the scandal VERDA is running out of control. In this world of daddy's boys and girls each one knows and supports the other one, and therefore, one preferred to protect without any hesitation the careers of the cronies, rather than to render justice! The Ticino is the canton with the highest density of Lawyers in Switzerland, and consequently this region is riddled the utmost of the judiciary dysfunction.

On December 7, 2000 Claudio MOLINARI sent his recourse to the Federal Court, requesting explicitly to be heard face to face. After months of silence, he relaunched a memorandum of some 100 pages, backing up all suffered irregularities, receipt acknowledged by the Federal Court on May 21st, 2001. On June 1st, 2001 he got the decision of the supreme court of this country, probably backdated May 15, 2001 (the invoice is dated May 31st, 2001 !): The federal «Judge» **M. SCHUBARTH**, assisted by his colleagues **R.M. SCHNEIDER** (a swindler and former guru of an Indian sect) and RAMELLI confirmed blindly the sentence of the inferior instances.

**Who is Martin SCHUBARTH? This citizen of Basle is the champion of perjury at the Federal Court. He is inventoried 14 times already in our «Reference List of Lawyers» for his lies and abuses of authority. Martin SCHUBARTH is a genuine machine of injustice at the Swiss Federal Court.**

In the meantime Claudio MOLINARI has denounced 3 investigators of the Police for their fraudulent job and the Attorney General of Ticino, Luca MARCELLINI is investigating or not investigating since one year. It is really painful to attack dear colleagues of the brotherhood!

Claudio MOLINARI has as well submitted a request to the European Court of Human Rights in Strasbourg. He has just phoned with the referenda of the Confederation of that institution, Mrs. M. ISELI (APPEAL TO THE PEOPLE is presently carrying out an audit directed against this government employee, suspected of collusion with the law offenders of the Swiss judiciary apparatus). Mrs. ISELI has replied to Claudio MOLINARI that he had to wait probably another year before the European Judges can take care of his case. Obviously, she is making fun with the victim.

**In conclusion the government and Parliament are requested, Mister President, to grant to Claudio MOLINARI immediately the revision of his trial, the suspension of the sentence, and his liberation, that is to say to take off the hands this case of the Lawyers of Ticino. It has to be transferred to a neutral court, composed of ad hoc extra-cantonal members. Provide to Claudio MOLINARI finally the fundamental right to be heard face to face. In the present case, his best Lawyer is he himself!**
