Role assumed in the affair LÉGERET

Laura JACQUEMOUD-ROSSARI did sit in the court of penal law of the Swiss supreme Federal Court which has rejected the recourse of François LÉGERET against the condemnation by the courts **COLELOUGH** / **EPARD** by decision of the Federal Court (ATF) 6B_683/2011 of November 20, 2011. She backslided in this affair three times more, rejecting recourses of **François LÉGERET** concerning further revision requests. This is concerning ATF 6B_118/2009, 6B_12/2011 of December 20, 2011, 6F_3/2012 of March 16, 2012 and 6B_731/2013 of November 28, 2013, always with the simple and comfortable procedure of «copy/paste».

As demonstrated with the case **Peter OTT**, our federal «Judges» need sometimes 10 passes for understanding a clear situation.

Profile

Born in 1957. A native of Geneva. Law degree from the University of Geneva. Lawyers license from the canton of Geneva in 1982. Practice of the Bar until January 1984. 1984 -1986: general prosecutor's substitute of the Republic and of the canton of Geneva. 1986 – 1989: investigating «Judge» before the first instance court. By June 1996 «judge» at the Court of Justice of Geneva (1996 – 2004), Civil Division, Section of Small Affairs and Chamber of Appeals for leases and rents; 2003 – 2005: «Judge» and «President» of the Indictment Chamber.

By June 2005, President of the Court of Justice and «Judge» of Civil Affairs of the 3rd Chamber of the Court. Elected Federal «Judge» on December 19, 2007 for the political party PDC.

She was already filed in our database at the time as a «Judge» in Geneva, for having covered up an abuse by two psychiatrists: The Ferdinand DOEBELI case. By decree of the Federal Court 6B_264/2011 of July 19, 2011, three federal «Judges», of whom JACQUEMOUD-ROSSARI, rejected a decision of the Vaudois cantonal court, and the same team gave right to the Vaudois, notwithstanding the unchanged situation, by ATF 6B_1/2012 of April 18, 2012: The **Kumar KOTECHA** case (British university professor).

Recidivism in another matter: Laura and others dismissed the Vaudois on the grounds that they had based it on «presumption and suspicion» (6B_825/2012 of May 8, 2012). After a repetition of these presumptions and suspicions by the Vaudois, and by unchanged situation, JACQUEMOUD-ROSSARI and Co. of the Criminal Law Division of the Federal Court approved them to be right (ATF 6B_451/2012 of October 29, 2012).

Such a course of inconsistency also leaves us to fear for the mental state of the perpetrators of such judgments.

It is therefore not surprising to see that same person plunge into three judicial crimes: she was one of the federal «Judges» who confirmed François LÉGERET's

life sentence for alleged triple murder, as well as **Laurent SÉGALAT**'s sentence for alleged murder, and she corroborated the conviction of Naghi GASHTIKHAH (ATF 6B_1007/2013 of September 2nd, 2015).
