JOMINI has made his career as Vaudois «Judge» during the second half of the 20<sup>th</sup> century, when the radical party was politically still clearly dominating in the canton of Vaud. He has been cantonal Judge during the reigns of the Attorney Generals Willy HEIM, Jean-Marc SCHWENTER and Eric COTTIER. The latter has been sponsored by JOMINI. Other close malefactors of JOMINI:

The Zofinguien Philippe LEUBA, actual State Councillor VD and Jacqueline DE QUATTRO, actual State Councillor VD, belonging to the Freemasonry.
