Former cantonal investigating «Judge» of Fribourg. After the judiciary reform early 2011 he was promoted Prosecutor of the canton of Fribourg. Political party PDC (the dominating local political power).

The fraud to the disadvantage of the AVS, covered by the Judges

Karl-Heinz REYMOND was a former policeman of Berlin, and he had had an appropriate experience in cases of the penal law and such investigations. Among others, he had discovered in the canton of Fribourg a case of swindle to the disadvantage of the social security AVS. An entrepreneur from Fribourg had cheated the AVS and other social insurances in complicity with one of his employees. He denounced this offense to be pursued officially by Swiss law, without success.

The investigating «Judge» JULMY from the canton of Fribourg covered intentionally this swindle. He simply suspended the investigation procedure by using a description of the facts which had been faked illegally. Since REYMOND did not abdicate, he was charged with judiciary fees. According to his own account, he has been milked with more than CHF 20'000 – not to mention the working hours invested in this struggle. Another investigating «Judge», André PILLER, threatened the «troublemaker» to be sent to a psychiatrist! REYMOND could not be impressed and continued the battle. Time going by, he accumulated experiences with almost all Judges of Fribourg, who got dirty in this affair. 4 federal Judges (**AEMISEGGER**, NAY, **SCHNEIDER** and JACOT-GUILLARMOD †) as well as two federal Prosecutors (ZINGLÉ, STADLER) are involved. In the year 2000 the canton of Fribourg had mandated the two extra-cantonal magistrates Gérard PIQUEREZ (JU) and Pierre CORNU (NE) to establish a survey about the deplorable state of its judiciary system. This case has been brought to the attention of those two experts. Nonetheless, this mess continued, without any prosecution. Up to date REYMOND continues his struggle. He has contacted all kinds of politicians, always by registered mail, among others the former and actual Minister of the canton of Fribourg, responsible for the Department of Justice. 6 Federal Councillors are involved. All have carried on this swindle and got guilty of illegally favouring wrongly acting government officials. In January 2012 the guilty investigating judge JULMY, having become in the meantime Deputy Prosecutor General FR lodged successfully a complaint against REYMOND for alleged offended honour! Once again, it was the world upside down!
