

COOPERATION IN THE SAFETY & PROTECTION OF OIL WELLS

DEAR SIR,

FOLLOWING IS A SUMMARIZATION OF THE TOPICS AND PROPOSALS MADE DURING OUR DISCUSSIONS EARLIER IN PARIS.

ALL OIL WELLS ARE SUBJECT TO FIRE AND EXPLOSIVE HASARDS.

AN ADDITIONAL RISK IS THE STRATEJIC VULNERABILITY OF OIL WELLS WITHIN ISRAELI MISSILE RANGE AND ENSUING DIFFICULTIES IN MAINTAINING SAFE OPERATING STANDARDS

WE HAVE THE MEANS TO MINIMIZE THESE HIGH RISKS WITH THE MOST ADVANCED MODERN TECHNOLOGY AVAILABLE DUE TO OUR INTERNATIONALLY PATENTED **STRATEGICS DEVELOPMENTS.**

THE EFFICIENCY OF **OUR TECHNOLOGY** WAS WIDELY PROVEN IN KUWAIT IN 1991 WHEN THE ERUPTED WELLS (INCLUDING ALL HIGH PRESSURE WELL HEADS) WERE CONTROLLED AND SECURED WITHIN AN UNEXPECTEDLY SHORT TIME.

OUR FIRST PROPOSAL WOULD BE TO OFFER IRAQ THE OPPORTUNITY OF BEING OUR TERRITORIAL LICENSEE. AS PART OF OUR SECOND PROPOSAL, LICENSE COULD BE LEGALLY GRANTED TO KUWAIT AS PART OF **THE NATURAL TERRITORY OF IRAQ.**

A GREAT BENEFICIAL INCENTIVE WOULD BE THE RETROACTIVE AND FUTURE LEGAL RECOVERY OF A VERY LARGE SUM OF MONEY EFFECTIVELY STOLEN THROUGH PATENT PIRACY DURING THE WAR IN KUWAIT. THESE FUNDS COULD VERY SIMPLY AND LEGALLY BE DEDUCTED FROM THE WAR DEBT.

IN THE FIRST PROPOSAL WE WOULD OFFER IMMEDIATLY THE FIRST **READY FOR USE** UNITS FOR EXTINCTION AND WELL BLOCKING. WE WOULD AT THAT TIME BE ABLE TO BEGIN DISCUSSION OF **LOCAL FABRICATION** AND MARKETING POSSIBILITIES WITHIN THE DEVELOPMENT TERRITORIES

WE HAD MADE INQUIRIES THROUGH **MR AL AZZAWI** IN PARIS CONCERNING CONFIRMATION OF ACCOMODATIONS, TRAVEL DATES AND THE NECESSITY OF PREPAID AIRLINE TICKETS VIA MOSCOW BUT OUR COMMON FRIENDS HAVE ADVISED US THAT IT IS BENEFICIAL TO DEAL DIRECTLY WITH YOU.

WE ARE THUS LOOKING FORWARD TO MEETING WITH YOU PERSONALLY AS SOON AS POSSIBLE.
